

## **NOTICE OF PUBLIC HEARING**

Acting under the authority of the Ohio Revised Code Sections 119.03 to 119.13, 3715.69, 3719.28, and 4729.26, the State Board of Pharmacy hereby announces a public hearing will be held on Monday, **November 2, 2009**, at 1:30 p.m. in Room South A, 31<sup>st</sup> Floor, Vern Riffe Center for Government and the Arts, 77 South High Street, Columbus, Ohio.

This is a statement of the agency's intention to consider adopting proposed new and amended rules as follows:

4729-5-16 (*Labeling of drugs dispensed on a prescription.*) To add language to clarify that the name of the patient and the prescriber means the full name.

4729-5-21 (*Manner of processing a prescription.*) To make technical language changes to clarify the rule. To add language that permits a licensed pharmacy intern to remove a prescription from a recording device.

4729-5-24 (*Prescription copy.*) To add language to clarify that the name of the patient and the prescriber means the full name. To make technical language changes to clarify the rule.

4729-5-27 (*Record keeping.*) To add a reference to rule 4729-5-38 of the Administrative Code for the purpose of identifying the immunizations a pharmacist or pharmacy intern may administer.

4729-5-30 (*Manner of issuance of a prescription.*) To add language to clarify that a patient address means a residential address.

4729-11-07 (*Standard pharmaceutical references.*) To remove the reference to the United States Pharmacopeia Dispensing Information since it is no longer available.

4729-15-01 (*Definitions.*) To make technical language changes to clarify the rule. To place the definitions in alphabetical order.

4729-15-03 (*Minimum standards for a nuclear pharmacy.*) To remove unnecessary language and to make technical language changes to clarify the rule.

4729-17-10 (*Labeling of prescriptions for patients of an institutional facility.*) To add language to clarify that the name of the patient means the full name. To allow the Board the ability to approve alternate methods on how pharmacies implement multiple-dose drug packaging systems.

4729-19-04 (*Minimum standards for compounding parenteral or sterile product prescriptions.*) To make technical language changes to clarify the rule.

4729-22-01 (*Licensure.*) To make technical language changes to clarify the rule.

4729-22-02 (*Security, storage, sale.*) To change the phrase "person authorized to prescribe oxygen" to the more widely accepted term "prescriber."

4729-22-04 (*Prescriber's order.*) To change the phrase "person authorized to prescribe oxygen" to the more widely accepted term "prescriber."

The Board also reviewed the following rules and proposed that no changes be made: 4729-9-21, 4729-12-01, 4729-12-02, 4729-12-03, 4729-12-04, 4729-12-05, 4729-12-08, 4729-12-09, 4729-12-10, 4729-19-01, 4729-19-02, 4729-19-03, 4729-21-01, 4729-21-02, 4729-21-03, 4729-21-04, 4729-21-05, 4729-21-06, 4729-22-03, 4729-25-01, 4729-25-02, 4729-25-03, 4729-25-04, 4729-29-02.
