# SETTLEMENT AGREEMENT WITH THE STATE BOARD OF PHARMACY (Docket Number D-120817-259)

This Settlement Agreement is entered into by and between Carl Lee Jesina and the Ohio State Board of Pharmacy, a state agency charged with enforcing the Pharmacy Practice Act and Dangerous Drug Distribution Act, Chapter 4729. of the Ohio Revised Code.

Carl Lee Jesina voluntarily enters into this Agreement being fully informed of his rights afforded under Chapter 119. of the Ohio Revised Code, including the right to representation by counsel, the right to a formal adjudication hearing on the issues contained herein, and the right to appeal. Carl Lee Jesina acknowledges that by entering into this Agreement he has waived his rights under Chapter 119. of the Revised Code.

Whereas, the Board is empowered by Section 4729.16 of the Ohio Revised Code to suspend, revoke, limit, place on probation, refuse to grant or renew an identification card or enforce a monetary penalty on the license holder for violation of any of the enumerated grounds therein.

Whereas, Carl Lee Jesina is licensed to practice pharmacy in the State of Ohio.

Whereas, on or about August 16, 2012, pursuant to Chapter 119. of the Ohio Revised Code, Carl Lee Jesina was notified of the allegations or charges against him, his right to a hearing, his rights in such hearing, and his right to submit contentions in writing. Carl Lee Jesina requested a hearing; it was scheduled and continued.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of a formal hearing at this time, Carl Lee Jesina knowingly and voluntarily agrees with the State Board of Pharmacy to the following:

Carl Lee Jesina hereby agrees to retire his license to practice pharmacy in the state of Ohio. In exchange for Carl Lee Jesina's agreement to retire his license, the Board will dismiss the allegations set forth in the Notice of Opportunity for Hearing letter issued on August 16, 2012 and hold the entire matter for naught. Carl Lee Jesina's record before the Board will not reflect disciplinary matters.

Carl Lee Jesina acknowledges that he has had an opportunity to ask questions concerning the terms of this Agreement and that all questions asked have been answered in a satisfactory manner. Any action initiated by the Board based on alleged violation of this Agreement shall comply with the Administrative Procedure Act, Chapter 119. of the Ohio Revised Code.

Carl Lee Jesina waives any and all claims or causes of action he may have against the State of Ohio or the Board, and members, officers, employees, and/or agents of either, arising out of matters which are the subject of this Agreement. Carl Lee Jesina waives any rights of appeal pursuant to Chapter 119. of the Ohio Revised Code.

This Settlement Agreement shall be considered a public record, as that term is used in Section 149.43 of the Ohio Revised Code, it SHALL NOT be considered disciplinary and will not be published by the Board. This Agreement shall become effective upon the date of the Board President's signature below.

# **FINDING OF FACT**

After having heard the testimony, observed the demeanor of the witnesses, considered the evidence, and weighed the credibility of each, the State Board of Pharmacy finds that Justin Allan Bracken has substantially complied with the terms set forth in the Order of the State Board of Pharmacy, Docket Number D-091006-019, effective December 8, 2009.

#### **DECISION OF THE BOARD**

On the basis of the Finding of Fact set forth above, and after consideration of the record as a whole, the State Board of Pharmacy hereby approves the reinstatement of the

pharmacist identification card, Number 03-2-26310, held by Justin Allan Bracken to practice pharmacy in Ohio subject to the following conditions:

- (A) Justin Allan Bracken must take and pass the North American Pharmacist Licensure Examination (NAPLEX) and the Multistate Pharmacy Jurisprudence Examination (MPJE) within one year from the date of the Order. Upon successful completion of the NAPLEX and MPJE, the indefinite suspension will be lifted and Justin Allan Bracken will be subject to a period of probation for five years, with the following requirements:
- (B) Justin Allan Bracken must enter into a <u>new</u> contract, signed within thirty days after the effective date of this Order, with an Ohio Department of Alcohol and Drug Addiction Services (ODADAS) approved treatment provider or a treatment provider acceptable to the Board for a period of not less than five years and submit a copy of the signed contract to the Board office before his pharmacist identification card is issued. The contract must provide that:
- (1) <u>Random</u>, <u>observed</u> urine drug screens shall be conducted at least once each month for the first year and then at least once every three months for the remaining four years.
- (a) The urine sample must be given within twelve hours of notification. The urine drug screen must include testing for creatinine or specific gravity of the sample as the dilutional standard.
- (b) Alcohol must be added to the standard urine drug screen. A Breathalyzer may be used to test for alcohol, but an appropriately certified individual must conduct the test within twelve hours of notification.
- (c) Results of all drug and alcohol screens must be negative. Refusal of a urine screen or a diluted urine screen is equivalent to a positive result. Any positive results, including those which may have resulted from ingestion of food, but excluding false positives which resulted from medication legitimately prescribed, indicates a violation of the contract.
- (2) The intervener/sponsor shall submit reports to the Board, in a format acceptable to the Board, indicating drug screens and their results in a timely fashion. Actual copies of drug screens shall be made available to the Board upon request.
- (3) Attendance is required a minimum of three times per calendar week (Sunday through Saturday), at an Alcoholics Anonymous, Narcotics Anonymous, and/or similar support group meeting.
- (4) The program shall immediately report to the Board any violations of the contract and/or lack of cooperation.

- (C) Justin Allan Bracken must submit quarterly progress reports to the Board (due January 10, April 10, July 10, and October 10 of each year of probation) that include:
- (1) The written report and documentation provided by the treatment program pursuant to the contract, and
- (2) A written description of Justin Allan Bracken's progress towards recovery and what Justin Allan Bracken has been doing during the previous three months.
- (D) Other terms of probation are as follows:
- (1) The State Board of Pharmacy hereby declares that Justin Allan Bracken's pharmacist identification card is not in good standing and thereby denies the privilege of being a preceptor and training pharmacy interns pursuant to paragraph (D)(1) of Rule 4729-3-01 of the Ohio Administrative Code.
- (2) Justin Allan Bracken may not serve as a responsible pharmacist.
- (3) Justin Allan Bracken may not destroy, assist in, or witness the destruction of controlled substances.
- (4) Justin Allan Bracken must abide by the contract with his treatment provider and must immediately report any violation of the contract to the Board.
- (5) Justin Allan Bracken must not violate the drug laws of Ohio, any other state, or the federal government.
- (6) Justin Allan Bracken must abide by the rules of the State Board of Pharmacy.
- (7) Justin Allan Bracken must comply with the terms of this Order.
- (8) Justin Allan Bracken's license is deemed not in good standing until successful completion of the probationary period.
- (E) Any violation of probation may result in a Board hearing to consider alternative or additional sanctions under Section 4729.16 of the Ohio Revised Code.

Justin Allan Bracken is hereby advised that the Board may at any time revoke probation for cause, modify the conditions of probation, and reduce or extend the period of probation. At any time during this period of probation, the Board may revoke probation for a violation occurring during the probation period.

#### **FINDINGS OF FACT**

After having heard the testimony, observed the demeanor of the witnesses, considered the evidence, and weighed the credibility of each, the State Board of Pharmacy finds the following to be fact:

(1) Records of the Board of Pharmacy indicate that Harold Eugene Fletcher was originally licensed in the State of Ohio on February 28, 1992, pursuant to examination, and Harold Eugene Fletcher's license to practice pharmacy in the State of Ohio was

summarily suspended effective March 21, 2012. Records further reflect Harold Eugene Fletcher was previously disciplined by the Board on May 12, 2003 and March 5, 2009.

(2) In accordance with Section 2929.42 of the Ohio Revised Code, this Board has received information which indicates that on January 9, 2012, Harold Eugene Fletcher was convicted of a felony drug abuse offense under 21 U.S.C. 84, to wit: Harold Eugene Fletcher was indicted for, plead guilty and was committed to the United States Bureau of Prisons for a term of (24) months for the Distribution of Oxycodone in violation of 21 U.S.C. 84 in the United States District Court, Southern District of Ohio, <u>United States v. Fletcher</u>, Case No. CR-2-10-249.

#### **CONCLUSIONS OF LAW**

- (1) The State Board of Pharmacy concludes that paragraph (2) of the Findings of Fact constitutes being guilty of a felony and gross immorality as provided in Division (A)(1) of Section 4729.16 of the Ohio Revised Code.
- (2) The State Board of Pharmacy concludes that paragraph (2) of the Findings of Fact constitutes being guilty of dishonesty and unprofessional conduct in the practice of pharmacy as provided in Division (A)(2) of Section 4729.16 of the Ohio Revised Code.
- (3) The State Board of Pharmacy concludes that paragraph (2) of the Findings of Fact constitutes being guilty of willfully violating, conspiring to violate, attempting to violate, or aiding and abetting the violation of provisions of Chapter 2925. of the Revised Code as provided in Division (A)(5) of Section 4729.16 of the Ohio Revised Code.

#### **DECISION OF THE BOARD**

Pursuant to Section 3719.121 of the Ohio Revised Code, the State Board of Pharmacy hereby removes the Summary Suspension Order issued to Harold Eugene Fletcher on March 21, 2012.

Pursuant to Section 4729.16 of the Ohio Revised Code, and after consideration of the record as a whole, the State Board of Pharmacy adjudicates the matter of Harold Eugene Fletcher as follows:

- (1) On the basis of the Findings of Fact and paragraph (1) of the Conclusions of Law, the State Board of Pharmacy hereby revokes permanently the pharmacist identification card, No. 03-1-19231, held by Harold Eugene Fletcher effective as of the date of the mailing of this Order.
- (2) On the basis of the Findings of Fact and paragraph (2) of the Conclusions of Law, the State Board of Pharmacy hereby revokes permanently the pharmacist
