FAXING PRESCRIPTIONS

Much to the chagrin and surprise of the Board office staff, a practicing pharmacist called to inquire about the ridiculous possibility of a prescription being faxed to a pharmacy by a prescriber's office. "Surely that is not allowed!" The pharmacist was surprised to learn that the Ohio Board has permitted the faxing of all prescriptions except Schedule II controlled substances to a pharmacy by a prescriber or prescriber's agent since July 1, 1990. The use of facsimile machines as an "other means of communication" of prescriptions and medication orders for controlled substances was first acknowledged by the federal Drug Enforcement Administration on May 19, 1994.

Recent changes in both the state and federal regulations regarding the faxing of prescriptions and the pharmacist's inquiry about this issue identified the need to address this topic in this newsletter. The last time this issue was discussed was in the May and August 1990 State Board Newsletters. Schedule II Controlled Substances

A Schedule II controlled substance prescription which has been faxed to a community pharmacy may be used <u>for informational purposes only</u> when dispensing oral dosage forms (e.g. - tablets, capsules, syrups, or suspensions) for ambulatory patients. Section 1306.11 of

Title 21 of the Code of Federal Regulations (CFR) does not permit a pharmacist to dispense the Schedule II controlled prescription <u>until</u> the original written, signed prescription has been received by the pharmacist. [21 CFR 1306.11(a)]

Schedule II controlled substance parenteral, intravenous, intramuscular, subcutaneous, or intraspinal prescriptions <u>that are to be compounded</u> for the direct administration to a patient that are faxed to a pharmacy serve as the original prescription and authorize the dispensing of the medication. The faxed prescription must be maintained in the same manner as other Schedule II controlled substance prescriptions. [21 CFR 1306.11(e)]

Schedule II controlled substance prescriptions for <u>residents</u> of Long Term Care Facilities may also be faxed to a pharmacy and the facsimile serves as the original prescription. The facsimile must be maintained in the same manner as all other Schedule II prescriptions. [21 CFR 1306.11(f)]

As of March 24, 1997, Schedule II controlled substance prescriptions written for <u>patients enrolled in a hospice</u> may be faxed to a pharmacist to authorize the dispensing of the drug pursuant to Federal regulations. Faxed Schedule II prescriptions for hospice patients serves as the original written prescription and is to be maintained with the other Schedule II prescriptions. The prescriber or the prescriber's agent must note on the faxed prescription that the patient is a "hospice patient". By the time you receive this newsletter, Ohio's rules will have been amended to reflect the federal rules regarding the faxing of Schedule II prescriptions for hospice patients. [21 CFR 1306.11(g)]

Schedule III, IV, and V Controlled Substances/Non-Controlled Prescription Drugs

These drugs may be dispensed pursuant to prescriptions faxed from a prescriber's office by either the prescriber or the prescriber's agent. The faxed prescription serves as the original prescription record and must be maintained for three years by the pharmacy.

Original prescriptions faxed to a pharmacy may not be given to the patient and are to be filed in the patient's records at the prescriber's office or at the institutional facility where it was issued by the prescriber. Faxed prescriptions are not legal unless such prescription is faxed directly to the pharmacy by either the prescriber or prescriber's agent. Agents faxing prescriptions for a prescriber must be identified by their full name on the faxed prescription record. [Ohio Administrative Code (OAC) Rule 4729-5-30; 21 CFR 1306.21]

<u>All prescriptions faxed</u> to a pharmacy must be signed by the practitioner in his/her own handwriting in order to be a valid authorization to dispense the medication ordered. The dispensing pharmacist is responsible for ensuring that the faxed prescription is valid and contains all of the information required by both federal and state regulations or rules. Questionable faxed prescriptions should not be dispensed by the pharmacist unless the prescriber has been contacted and the prescription determined to be valid.

Transferring Prescriptions (OAC Rule 4729-5-24)

Pharmacists may also use facsimiles to transfer prescription copies. The prescription copy faxed to the other pharmacy must include the serial prescription number assigned by the pharmacy dispensing the original prescription; name and address of the pharmacy transferring the prescription; date of issuance of the prescription; date of original dispensing as well as number of refills permitted; date of last refill; number of valid refills left; and the name of the transferring pharmacist.
