

Drug Shortage Guidance

Updated 6/2/2022

Due to supply chain issues, hospitals, clinics, and other healthcare facilities may experience shortages of drugs necessary to care for patients. The Board of Pharmacy has developed the following guidance to assist licensees in obtaining drugs that may not be commercially available from manufacturers or wholesalers.

Drug Shortages

Manufacturers provide the FDA with most of the drug shortage information. You can obtain information on reported drug shortages by visiting the FDA's website, including expected production date and extended use dates: https://www.fda.gov/drugs/drug-safety-and-availability/drug-shortages

Outsourcing Facilities

Outsourcing facilities are Ohio-licensed businesses that are registered by the U.S. Food and Drug Administration (FDA) to compound sterile and non-sterile drugs for sale to hospitals, physicians, clinics, or other healthcare facilities.

According to the FDA, outsourcing facilities are authorized to compound any drug that is on the FDA's <u>drug shortage list</u>. Specifically, the agency states:

The agency also does not consider a compounded drug produced by an outsourcing facility as "essentially a copy" if it is identical or nearly identical to an FDA-approved drug that is on FDA's <u>drug shortage list</u>. The agency also does not intend to take action under this provision if the facility fills orders for a compounded drug that is essentially a copy of an approved drug that has been discontinued and is no longer marketed.

A terminal distributor of dangerous drugs (or any prescriber who is <u>exempt</u> from licensure) is permitted to buy compounded drugs, including those on the FDA's drug shortage list (or that have been discontinued or no longer marketed), from an outsourcing facility currently licensed by the Board of Pharmacy (a list of currently licensed outsourcing facilities is available at the end of this document).



How to Locate an Outsourcing Facility Producing Drugs in Shortage

Outsourcing facilities are required to provide FDA with a list of drugs they compounded during the previous six-month period upon initial registration and in June and December each year. This <u>database</u> contains information reported to FDA within the last three years (last six reporting periods). This information may be used to identify outsourcing facilities that have produced certain drugs that are currently in shortage.

NOTE: This retrospective information does not identify drugs that outsourcing facilities intend to produce in the future.
