



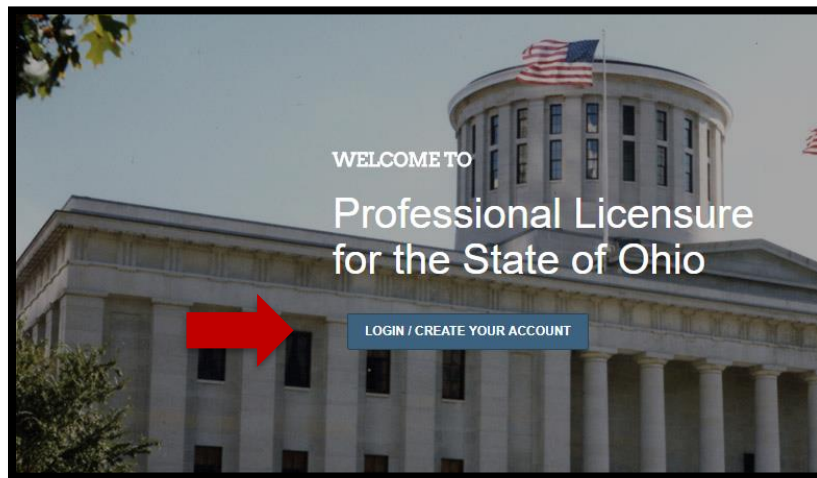

eLICENSE GUIDE: APPLYING FOR A CHANGE IN BUSINESS DESCRIPTION

Updated 1-11-2019

Access the portal using the eLicense system at <https://elicense.ohio.gov/>

Once you navigate to the main page, click on the blue button over the picture that says: **"LOG IN/CREATE YOUR ACCOUNT."**



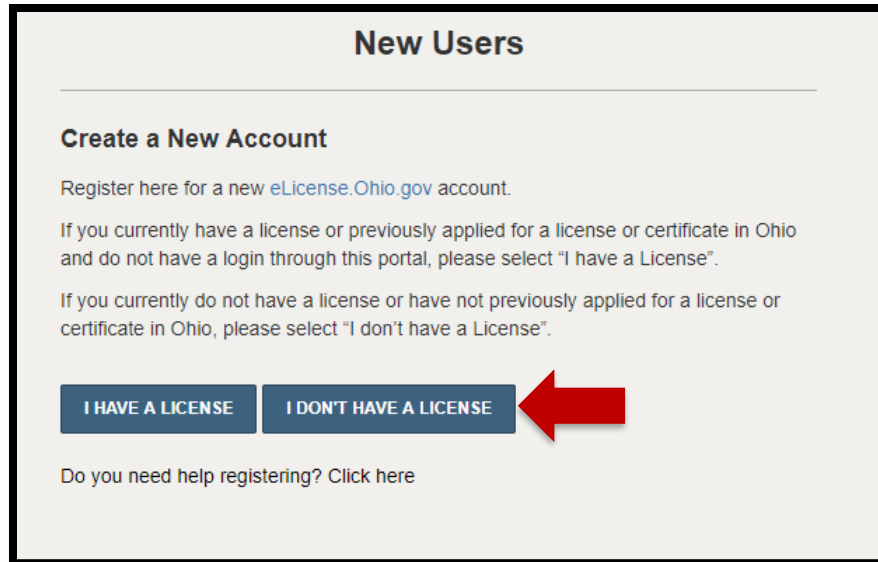
If this is your **FIRST TIME** using the new eLicense Ohio portal, you will need to register your contact information. To do so, follow the instructions in **PART A** of this guide.

NOTE: You will need to create a personal eLicense account under your name, regardless if you are applying for a business license. If you are a licensed healthcare professional in the State of Ohio; ie. Nurse, Pharmacist, Doctor, etc. – You will use your CURRENT eLicense login information.

PART A: CREATING AN ACCOUNT

Select, "I DON'T HAVE A LICENSE" and follow the instructions.



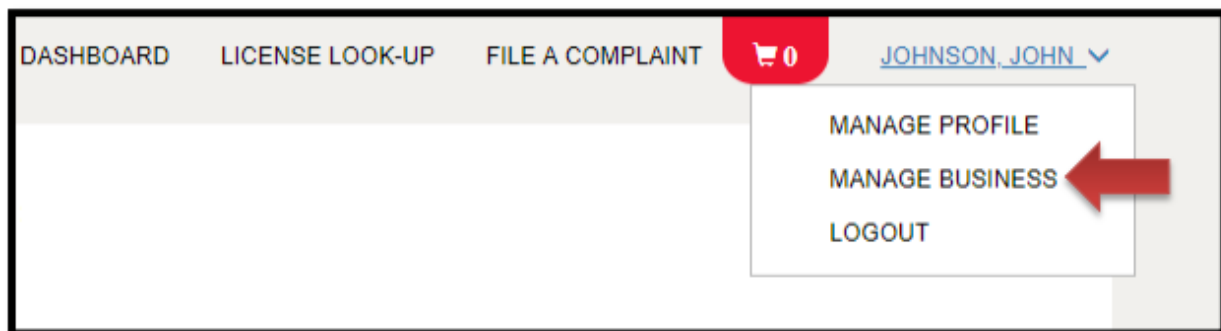


After registration, you will then be directed to your dashboard.

PART B: ATTACHING EXISTING BUSINESS LICENSE TO DASHBOARD

Create an account, following instructions from **PART A** of this guide or login to the eLicense portal with your current login information. If the license is already attached to your dashboard, proceed to **PART C** of this guide.

Select the drop-down menu beside your name in the upper right-hand corner.



Select '**MANAGE BUSINESS**'

Select '**ADD EXISTING BUSINESS**' enter the business security code and select, **SUBMIT**.

Add Existing Business

You can add an existing business if it has been previously registered. To do so, enter your security code and click 'Submit'. If you do not have your security code, click 'Obtain Security Code.'

Security Code

NOTE: To attach an existing business license to a user's dashboard, the user must have the business's unique security code.

If the user does not have this security code, select **OBTAIN SECURITY CODE**. The user can either select to enter the businesses current e-mail address that is on file with the Board for correspondence OR by entering the businesses FEIN number.

Add Existing Business

You can add an existing business if it has been previously registered. To do so, enter your security code and click 'Submit'. If you do not have your security code, click 'Obtain Security Code.'

* Security Code

If the **OBTAIN SECURITY CODE** feature does NOT work, please send an email to new.license@pharmacy.ohio.gov and include the license number to request the security code.

Once you have successfully entered the security code, return to your **DASHBOARD** and the license tile will be displayed.

PART C: SUBMITTING A CHANGE IN BUSINESS DESCRIPTION APPLICATION

Change in business description include the following:

- **CHANGE OF BUSINESS NAME**
- **CHANGE OF ADDRESS**
- **CHANGE OF OWNERSHIP**
- **CHANGE OF CATEGORY**

From your dashboard, select **OPTIONS** beside the license tile in which you need to submit a change, then select **CHANGE IN BUSINESS DESCRIPTION**.

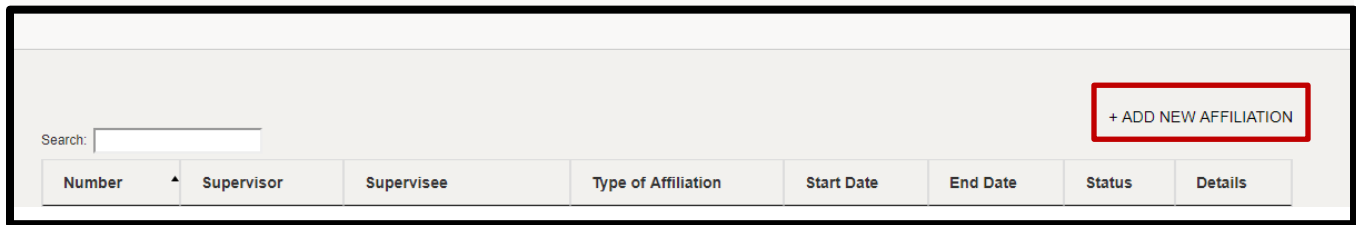

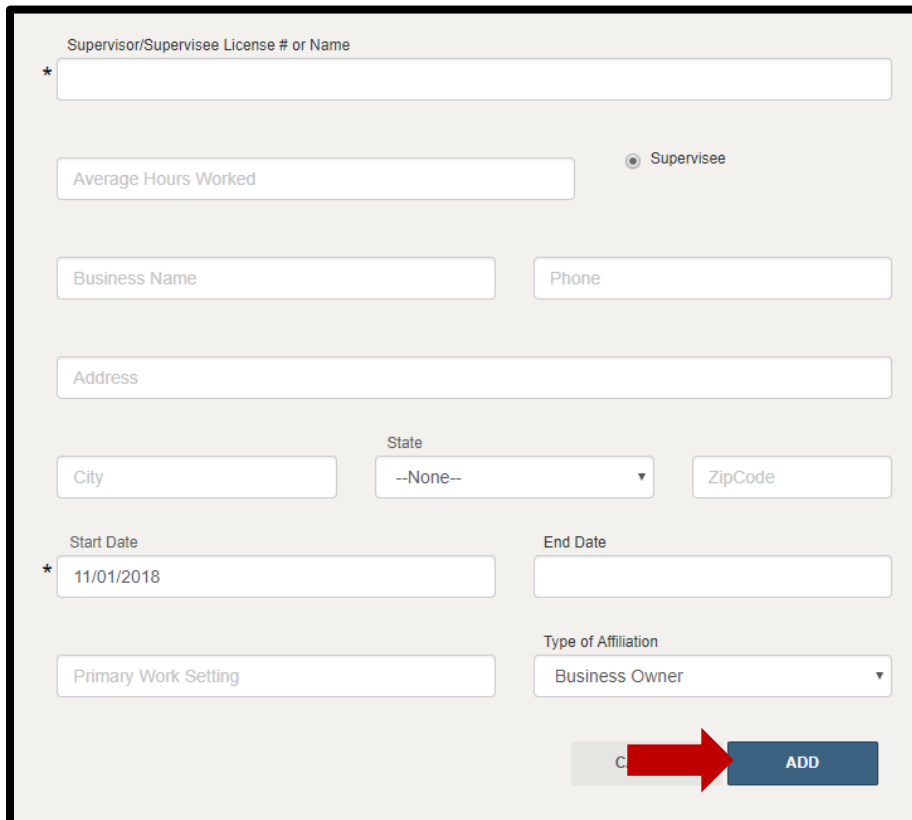
