### **Compliance Specialist Position Open in SW Ohio Region (Clark, Greene, Miami and Montgomery Counties)**

This Specialist position is assigned to the Southwest region of Ohio and includes the following counties: Adams, Brown, Butler, Champaign, Clark, Clermont, Clinton, Darke, Fayette, Greene, Hamilton, Highland, Logan, Madison, Miami, Montgomery, Preble, Shelby, Union and Warren Counties. The headquarter county location assigned for this position is Clark, Greene, Miami and Montgomery Counties. The final candidate selected for this position is required to live in or relocate to Clark, Greene, Miami or Montgomery County within 180 days from the effective date of hire.

### **REMINDER: Rule Reorganization Crosswalk Available**

In 2016, the State of Ohio Board of Pharmacy voted to authorize the reorganization of its administrative rules. The goal of this reorganization was to ensure that licensees could better identify rules applicable to the various practice settings/professions regulated by the Board.

As this process is now complete, the Board recently published a crosswalk document ([www.pharmacy.ohio.gov/crosswalk](http://www.pharmacy.ohio.gov/crosswalk)). The document includes links to the reorganized Board of Pharmacy rules, the effective date of the reorganized rules, and links to the previous version of the rules that were in effect prior to the reorganization (if applicable).
