MONDAY, APRIL 21, 1997

8:15 a.m. ROLL CALL

The State Board of Pharmacy convened in Room C-5, Ohio Departments Building, 65 South Front Street, Columbus, Ohio with the following members present:

Suzanne L. Neuber, R.Ph. (President); Amonte B. Littlejohn, R.Ph. (Vice-President); Robert Cavendish, R.Ph.; John Hanna, R.Ph.; Paul Lamping, R.Ph.; Ruth Plant, R.Ph.; and Nicholas Repke, Public Member.

Also present were: Mary Hollern, Assistant Attorney General; William Winsley, Assistant Executive Director; Tim Benedict, Compliance Administrator; and Robert Cole, Compliance Supervisor.

Mrs. Plant moved that the Board go into Executive Session for the purpose of conferring with the Assistant Attorney General regarding pending and imminent court matters and the investigation of complaints regarding licensees and registrants. The motion was seconded by Mr. Cavendish and a roll call vote was conducted by President Neuber as follows: Cavendish-Yes, Hanna-Yes, Lamping-Yes, Littlejohn-Yes, Plant-Yes, and Repke-Yes.

9:29 a.m.

Due to the poor acoustics in Room C-5, the meeting was recessed and moved to Room C-12. The Board meeting was continued in Executive Session.

9:35 a.m.

RES. 97-140 The Executive Session was concluded and the meeting opened to the public. President Neuber reported that a request for a continuance in the matter of Anthony Savoca, R.Ph. was denied and the 119. Hearing would be conducted as scheduled at 1:00 p.m.

The Board directed the Assistant Attorney General to finalize a settlement proposal in the matter of Frederick J. Weik pursuant to conditions stipulated by the Board during the Executive Session discussions.

RES. 97-141 Mr. Repke moved that the Board not accept the proposed settlement in the matter of Phillip W. Broerman and that the hearing be held as scheduled at 10:00 a.m. on Wednesday, April 23, 1997. The motion was seconded by Mr. Hanna and approved by the Board (Aye-6/Nay-0).

Mr. Lamping moved that the Board authorize the Assistant Attorney General to present the Board's terms for settling the matter of Mark Jeffrey Schirtzinger, R.Ph.; Xenia. Mrs. Plant seconded the motion and it was approved (Aye-6/Nay-0).

Mr. Lamping then moved that the Board authorize the Assistant Attorney General to present the Board's terms for settlements in the matters of Good Samaritan Hospital (Terminal Distributor License No. 02-0306050); Bethesda Hospital North (Terminal Distributor License No. 02-0032100); and Bethesda Hospital (Terminal Distributor License No. 02-0030200). Mr. Cavendish seconded the motion and it was approved (Aye-5/Nay-0). Mr. Hanna did not vote since he excused himself from the meeting and left during the discussion of these matters.

RES. 97-142 The Executive Director reported that the following settlement was entered into by the Board:

This Settlement Agreement is entered into by and between Ralph Lee LeVange and the Ohio State Board of Pharmacy, a state agency charged with enforcing the Pharmacy Practice Act and Dangerous Drug Distribution Act, Chapter 4729. of the Ohio Revised Code.

Ralph Lee LeVange enters into this Agreement being fully informed of his rights afforded under Chapter 119. of the Ohio Revised Code, including the right to representation by counsel and the right to a formal adjudication hearing on the issues contained herein.

Ralph Lee LeVange is knowingly and voluntarily acknowledging that, in order to settle the disciplinary charges that have been filed by the Board against Ralph Lee LeVange and in order to obviate the need to conduct an administrative hearing to consider possible disciplinary sanctions against Ralph Lee LeVange's license to practice pharmacy in the state of Ohio, this Agreement is entered into on the basis of the following stipulations, admissions, and understandings:

(A) The Ohio State Board of Pharmacy is empowered by Section 4729.16 of the Ohio Revised Code to suspend, revoke, place on probation, refuse to grant or renew an identification card, or impose a monetary penalty on the license holder for violation of any of the enumerated grounds.

(B) On or about July 30, 1996, pursuant to Chapter 119. of the Ohio Revised Code, Ralph Lee LeVange was notified of the allegations or charges against him, his right to a hearing, his rights in such hearing, and his right to submit contentions in writing. Further, a hearing was requested and scheduled for December 5, 1996; however, the hearing was continued by the Board.

(C) Ralph Lee LeVange neither admits nor denies the allegations stated in the Notice of Opportunity for hearing letter; however, the Board has evidence sufficient to sustain the allegations and hereby adjudicates the same:

(1) Records of the Board of Pharmacy indicate that Ralph Lee LeVange was originally licensed in the state of Ohio on March 26, 1979, pursuant to reciprocity, was lapsed from September 15, 1989 to September 9, 1992, and again from September 15, 1992, to October 5, 1992; and, Ralph Lee LeVange is currently licensed to practice pharmacy in the state of Ohio. Records further reflect that Ralph Lee LeVange was the Responsible Pharmacist at K-Mart Pharmacy in Troy, Ohio, pursuant to Sections 4729.27 and 4729.55 of the Ohio Revised Code and Rule 4729-5-11 of the Ohio Administrative Code during the periods alleged herein.

(2) Ralph Lee LeVange did, from October 12, 1987, through November 25, 1988, with purpose to deprive, knowingly obtain or exert control over the property of K-Mart, by deception, the value being over \$5,000.00, to wit: Ralph Lee LeVange created false prescriptions through K-Mart's computer for himself, his wife, and his two sons, for the purpose of submitting false

insurance claims in the amount of \$13,285.72. Such conduct is in violation of Section 2913.02 of the Ohio Revised Code.

(3) Ralph Lee LeVange did, on or about the following dates, intentionally make and knowingly possess false or forged prescriptions, to wit: Ralph Lee LeVange created the following false prescriptions for a controlled substance through K-Mart's computer for the purpose of submitting false insurance claims:

Such conduct is in violation of Section 4729.61(C) of the Ohio Revised Code.

(5) Ralph Lee LeVange was, pursuant to a plea agreement on or about February 5, 1991, convicted in the Common Pleas Court of Miami County, Ohio, of Theft in violation of Section 2913.02 of the Ohio Revised Code, a misdemeanor of the first degree.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any formal proceedings at this time, Ralph Lee LeVange knowingly and voluntarily agrees with the State Board of Pharmacy to the following:

- (1) The indefinite suspension of the pharmacist identification card, No. 03-1-12771, held by Ralph Lee LeVange indefinitely and such suspension is effective as of December 5, 1996. Pursuant to Rule 4729-9-01(F) of the Ohio Administrative Code, Ralph Lee LeVange may not be employed by or work in a facility licensed by the Board to possess or distribute dangerous drugs during such period of suspension. Division (B) of Section 4729.16 of the Revised Code provides that: "Any individual whose identification card is revoked, suspended, or refused, shall return his identification card and certificate of registration to the offices of the state board of pharmacy within ten days after receipt of the notice of such action." The certificate and identification card should be forwarded by certified mail, return receipt requested. Further, Ralph Lee LeVange must petition the Board, pursuant to a Revised Code Chapter 119. hearing, for reinstatement of his license to practice pharmacy in Ohio.
- (2) The imposition of a monetary penalty of five hundred dollars (\$500.00) due and owing within 30 days of the effective date of this Agreement. The monetary penalty should be made payable to the "Treasurer, State of Ohio" and mailed with the enclosed form to the State Board of Pharmacy, 77 S. High Street, 17th Floor, Columbus, Ohio 43266-0320.

If, in the judgment of the Board, Ralph Lee LeVange appears to have violated or breached any terms or conditions of this Agreement, the Ohio State Board of Pharmacy reserves the right to, at any time, institute formal disciplinary proceedings for any and all possible violations or breaches, including but not limited to, alleged violation of the laws of Ohio occurring before the effective date of this Agreement.

Ralph Lee LeVange acknowledges that he has had an opportunity to ask questions concerning the terms of this agreement and that all questions asked have been answered in a satisfactory manner. Any action initiated by the Board based on alleged violation of this Agreement shall comply with the Administrative Procedure Act, Chapter 119. of the Ohio Revised Code.

Ralph Lee LeVange waives any and all claims or causes of action he may have against the State of Ohio or the Board, and members, officers, employees, and/or agents of either, arising out of matters which are the subject of this Agreement.

In the event the Board, in its discretion, does not adopt this Agreement as its Adjudication, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. Ralph Lee LeVange agrees that should the Board reject this Agreement and if this case proceeds to hearing, he will assert no claim that the Board was prejudiced by its review and discussion of this Agreement or of any information relating thereto.

This Settlement Agreement shall be considered a public record, as that term is used in Section 149.43 of the Ohio Revised Code, and shall become effective upon the date of the Board President's signature below.

FINDINGS OF FACT

After having heard the testimony, considered the evidence, observed the demeanor of the witnesses, and weighed their credibility, the State Board of Pharmacy finds the following to be fact:

- (1) Records of the Board indicate that Anthony Savoca was originally licensed to practice pharmacy in the state of Ohio on March 14, 1962; and, on June 12, 1996, Anthony Savoca's license was summarily suspended in accordance with Section 3719.121(B) of the Ohio Revised Code.
- (2) Anthony Savoca did, from March 22, 1996, through May 16, 1996, knowingly sell a controlled substance in an amount equal to or exceeding three times the bulk amount, but in an amount less than one hundred times that amount, when the conduct was not in accordance with Chapters 3719., 4729., and 4731. of the Ohio Revised Code, to wit: Anthony Savoca sold 270 Diazepam 10mg tablets and 600 Diazepam 5mg tablets to his girlfriend without valid prescriptions. Such conduct is in violation of Section 2925.03(A)(7) of the Ohio Revised Code.
- (3) Anthony Savoca did, from March 22, 1996, through May 8, 1996, knowingly sell a controlled substance in an amount less than the minimum bulk amount when the conduct was not in accordance with Chapters 3719., 4729., and 4731. of the Ohio Revised Code, to wit: Anthony Savoca sold 30 Alprazolam 0.25mg tablets and 90 Alprazolam 0.5mg tablets to his girlfriend without valid prescriptions. Such conduct is in violation of Section 2925.03(A)(1) of the Ohio Revised Code.
- (4) Anthony Savoca did, on or about the following dates, intentionally create and/or knowingly possess false or forged prescriptions, to wit: to cover his thefts and trafficking in drugs, Anthony Savoca created and possessed in the computer at

Revco Discount Drug Center #339, 21925 Lorain Road, Fairview Park, Ohio the following computer records purporting to be prescriptions:

Such conduct is in violation of Section 2913.42 of the Ohio Revised Code.

FINDINGS OF FACT

After having heard the testimony, considered the evidence, observed the demeanor of the witnesses, and weighed their credibility, the State Board of Pharmacy finds the following to be fact:

- (1) Records of the Board of Pharmacy indicate that Stephen Robert Chikosky was originally licensed in the state of Ohio on March 27, 1984, pursuant to reciprocity, and is currently licensed to practice pharmacy in the state of Ohio.
- (2) Stephen Robert Chikosky did, on or about May 30, 1996, knowingly sell a controlled substance in an amount equal to or exceeding three times the bulk amount, but in an amount less than one hundred times that amount when the conduct was not in accordance with Chapters 3719., 4729., and 4731. of the Revised Code, to wit: Stephen Robert Chikosky sold 120 units of Vicodin ES pursuant to false or forged prescription number 4414810, using a duplicate label from a previous dispensing of that prescription, without recording the sale in the pharmacy's dispensing record and without having a new prescription from a practitioner. Such conduct is in violation of Section 2925.03(A)(7) of the Ohio Revised Code.
- (3) Stephen Robert Chikosky did, on or about September 4, 1996, knowingly sell a controlled substance in an amount exceeding the bulk amount but less than five times the bulk amount when the conduct was not in accordance with Chapters 3719., 4729., and 4731. of the Ohio Revised Code, to wit: Stephen Robert Chikosky sold 90 units of Vicodin ES pursuant to false or forged prescription number 4415650, using a duplicate label from a previous dispensing of that prescription, without recording the sale in the pharmacy's dispensing record and without having a new prescription from a practitioner. Such conduct is in violation of Section 2925.03(A) of the Ohio Revised Code.
- (4) Stephen Robert Chikosky did, on or about May 30, 1996, intentionally create and/or knowingly possess a false or forged prescription, to wit: Stephen Robert Chikosky created and possessed on file prescription number 4414810, using a duplicate label from a previous dispensing of that prescription, without recording the sale in the pharmacy's dispensing record and without having a new prescription from a practi-

tioner. Such conduct is in violation of Section 2925.23(B)(1) of the Ohio Revised Code.

- (5) Stephen Robert Chikosky did, on or about September 4, 1996, intentionally create and/or knowingly possess a false or forged prescription, to wit: Stephen Robert Chikosky created and possessed on file prescription number 4415650, using a duplicate label from a previous dispensing of that prescription, without recording the sale in the pharmacy's dispensing record and without having a new prescription from a practitioner. Such conduct is in violation of Section 2925.23(B)(1) of the Ohio Revised Code.

CONCLUSIONS OF LAW

- (1) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraphs (2) through (5) of the Findings of Fact constitute being guilty of dishonesty and unprofessional conduct in the practice of pharmacy as provided in Division (A)(2) of Section 4729.16 of the Ohio Revised Code.
- (2) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraphs (2) through (5) of the Findings of Fact constitute being guilty of willfully violating, conspiring to violate, attempting to violate, or aiding and abetting the violation of provisions of Chapter 2925. of the Revised Code as provided in Division (A)(5) of Section 4729.16 of the Ohio Revised Code.

ACTION OF THE BOARD

Pursuant to Section 4729.16 of the Ohio Revised Code, the State Board of Pharmacy takes the following actions in the matter of Stephen Robert Chikosky:

- (A) On the basis of the Findings of Fact and paragraph (1) of the Conclusions of Law set forth above, the State Board of Pharmacy hereby places the pharmacist identification card, No. 03-2-15373, held by Stephen Robert Chikosky on probation for two years, effective as of the date of the mailing of this Order. The terms of probation are as follows:
 - (1) Pursuant to paragraph (D)(1) of Rule 4729-3-01 of the Ohio Administrative Code, the State Board of pharmacy hereby declares that Stephen Robert Chikosky's pharmacist identification card is not in good standing and thereby denies the privilege of being a preceptor and training pharmacy interns.
 - (2) Stephen Robert Chikosky may not serve as a responsible pharmacist.
 - (3) Stephen Robert Chikosky must not violate the drug laws of the state of Ohio, any other state, or the federal government.
 - (4) Stephen Robert Chikosky must abide by the rules of the Ohio State Board of Pharmacy.
 - (5) Stephen Robert Chikosky must comply with the terms of this Order.

The Board may at any time revoke probation for cause, modify the conditions of probation, and reduce or extend the period of probation. At any time during this period of probation, the Board may revoke probation for a violation occurring during the probation period.

- (B) On the basis of the Findings of Fact and paragraph (2) of the Conclusions of Law set forth above, the State Board of Pharmacy hereby imposes a monetary penalty of five hundred dollars (\$500.00) due and owing within thirty days of the issuance of this Order. The monetary penalty should be made payable to the "Treasurer, State of Ohio" and mailed with the enclosed form to the State Board of Pharmacy, 77 South High Street, 17th Floor, Columbus, Ohio 43266-0320.

FINDINGS OF FACT

After having heard the testimony, considered the evidence, observed the demeanor of the witnesses, and weighed their credibility, the State Board of Pharmacy finds the following to be fact:

- (1) Records of the Board indicate that Phillip William Broerman was originally licensed to practice pharmacy in Ohio on February 23, 1990, and on January 3, 1997, his license was summarily suspended in accordance with Section 3719.121(C) of the Ohio Revised Code.
- (2) Phillip William Broerman was convicted, on or about November 26, 1996, in the Common Pleas Court of Hamilton County, Ohio, of Theft of Drugs in violation of Section 2913.02 of the Ohio Revised Code, a felony of the fourth degree.
- (3) Phillip William Broerman did, on or about October 6, 1996, knowingly obtain, possess, or use a controlled substance when the conduct was not in accordance with Chapters 3719., 4729., and 4731. of the Ohio Revised Code, to wit: Phillip William Broerman possessed and/or used one unit of Diazepam 5mg without having a prescription for the medication and without a legitimate medical purpose. Such conduct is in violation of Section 2925.11 of the Ohio Revised Code.
- (4) Phillip William Broerman did, on or about October 6, 1996, possess dangerous drugs when the conduct was not in accordance with Chapters 4729. and 4731. of the Ohio Revised Code, to wit: Phillip William Broerman possessed and/or used Carisoprodol 350mg tablets without having a prescription for the medication and without a legitimate medical purpose. Such conduct is in violation of Section 4729.51(C)(3) of the Ohio Revised Code.
- (5) Phillip William Broerman did, October 6, 1996, operate a motor vehicle in this state while under the influence of alcohol and/or drugs of abuse, to wit: Phillip William Broerman was arrested for OMVI and subsequently convicted. Such conduct is a first degree misdemeanor in violation of Section 4511.19 of the Ohio Revised Code.
- (6) Phillip William Broerman did, on or about October 6, 1996, with purpose to deprive, knowingly obtain or exert control over dangerous drugs, the property of Walgreens, beyond the express or implied consent of the owner, to wit: Phillip William Broerman stole 30 units of Carisoprodol 350mg and one unit of Diazepam 5mg from his employing pharmacy. Such conduct is in violation of Section 2913.02 of the Ohio Revised Code.
- (7) Phillip William Broerman did, on or about August 25, 1996, intentionally make and/or knowingly possess a false or forged prescription, to wit: Phillip William Broerman forged prescription number 1058849 for 30 units of Propoxyphene 65mg, a schedule IV controlled substance, to cover for his theft of the drugs. Such conduct is in violation of Section 2925.23(B)(1) of the Ohio Revised Code.
- (8) Phillip William Broerman did, on or about October 5, 1996, knowingly make a false statement in a prescription, report, or record required by Chapter 4729. of the Revised Code, to wit: Phillip William Broerman forged prescription number 1072742 for 30 units of Carisoprodol 350mg, a dangerous drug, to cover for his theft of the drugs. Such conduct is in violation of Section 2925.23(A) of the Ohio Revised Code.
- (9) Phillip William Broerman did, on or about October 5, 1996, intentionally make and/or knowingly possess a false or forged prescription, to wit: Phillip William Broerman forged prescription number 1072743 for 3 units of Diazepam 5mg, a schedule IV controlled substance, to cover for his theft of the drugs. Such conduct is in violation of Section 2925.23(B)(1) of the Ohio Revised Code.
- (10) Phillip William Broerman did, on or about October 6, 1996, misbrand a drug, to wit: Phillip William Broerman placed 25 units of Carisoprodol into an unlabeled vial and removed the vial from the pharmacy in which he worked. Such conduct is in violation of Section 3715.52 of the Ohio Revised Code.

CONCLUSIONS OF LAW

- (1) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraph (2) of the Findings of Fact constitutes being guilty of a felony as provided in Division (A)(1) of Section 4729.16 of the Ohio Revised Code.
- (2) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraphs (3), (4), and (6) through (10) of the Findings of Fact constitute being guilty of unprofessional conduct in the practice of pharmacy as provided in Division (A)(2) of Section 4729.16 of the Ohio Revised Code.
- (3) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraph (5) of the Findings of Fact constitutes being impaired to such a degree as to render him unfit to practice pharmacy as provided in Division (A)(3) of Section 4729.16 of the Ohio Revised Code.
- (4) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraphs (3), (4), and (7) through (10) of the Findings of Fact constitute being guilty of willfully violating, conspiring to violate, attempting to violate, or aiding and abetting the violation of provisions of Sections 3715.52 to 3715.72 or Chapter 2925. or 4729. of the Revised Code as provided in Division (A)(5) of Section 4729.16 of the Ohio Revised Code.

ACTION OF THE BOARD

Pursuant to Section 3719.121 of the Ohio Revised Code, the State Board of Pharmacy hereby removes the Summary Suspension Order issued January 3, 1997.

Pursuant to Section 4729.16 of the Ohio Revised Code, and on the basis of the Findings of Fact and Conclusions of Law set forth above, the State Board of Pharmacy hereby places the pharmacist identification card, No. 03-2-18165, held by Phillip William Broerman on probation for two years, effective as of the date of the release of his license. The terms of probation are as follows:

- (A) Phillip William Broerman must enter into a contract to obtain random urine drug screens with an ODADAS approved laboratory or an approved treatment provider acceptable to the Board for a period of not less than two years. Upon receipt of a copy of the signed contract, the Board will release the license of Phillip William Broerman. The contract must provide that:
 - (1) Random, **observed** urine screens shall be conducted at least once every three months. The urine drug screens must report testing for creatinine as the dilutional standard or specific gravity;
 - (2) The laboratory/treatment provider shall provide copies of all urine screens to the Ohio Board of Pharmacy in a timely fashion; and
 - (3) The laboratory/treatment provider shall immediately report to the Ohio Board of Pharmacy any violations of the contract and/or lack of cooperation.
- (B) Other terms of probation are as follows:
 - (1) Phillip William Broerman must abide by the contract from the treatment provider and any violation must be reported to the Board immediately.
 - (2) Phillip William Broerman must not violate the drug laws of the state of Ohio, any other state, or the federal government.
 - (3) Phillip William Broerman must abide by the rules of the Ohio State Board of Pharmacy.

(4) Phillip William Broerman must comply with the terms of this Order.

Phillip William Broerman is hereby advised that the Board may at any time revoke probation for cause, modify the conditions of probation, and reduce or extend the period of probation. At any time during this period of probation, the Board may revoke probation for a violation occurring during the probation period.

THIS ORDER WAS APPROVED BY A VOTE OF THE STATE BOARD OF PHARMACY.

RES. 97-162 The Board then proceeded to elect officers for FY 98 pursuant to Internal Management Rule 4729-2-01. Amonte Littlejohn was elected President and Joseph Maslak was elected Vice-President of the Board.

RES. 97-163 The Board was joined by Robert L. Cole, Compliance Supervisor for the Board. Mr. Cole presented information discovered by Compliance Agent David Gallagher regarding electronic alarm systems that are being used to secure pharmacies. Agent Gallagher reported that it appears that a new industry standard for such systems provides for a "Bypassing Protection Zones" feature. Following discussion, the Board directed staff that such systems cannot be approved to secure pharmacies and dangerous drugs unless such feature is disabled by the alarm company when the system is installed. Further such feature may not be enabled at any time by anyone following approval of the security system by a Board agent.
