**MONDAY, AUGUST 11, 1997**

8:00 a.m. ROLL CALL

The State Board of Pharmacy convened in Room C-11, Ohio Departments Building, 65 South Front Street, Columbus, Ohio with the following members present:

Joseph J. Maslak, R.Ph. (Vice-President); Diane Adelman, R.Ph.; Robert Cavendish, R.Ph.; Paul Lamping, R.Ph.; Suzanne Neuber, R.Ph.; Ruth Plant, R.Ph.; and Nicholas Repke, Public Member.

Mr. Maslak, Vice-President, presided in the absence of the Board President.

The Board was joined by Assistant Attorney General Mary Hollern for the purpose of conducting an adjudication hearing pursuant to Chapters 119. and 4729. of the Revised Code in the matter of Peter Corpus, R.Ph., Columbus.

8:15 a.m.

The hearing was recessed to allow the Board to review the documentation submitted by Mr. Corpus in support of his reinstatement petition.

8:20 a.m.

Board President Amonte Littlejohn and Board member John Hanna arrived. With the agreement of Mr. Corpus, Mr. Littlejohn assumed the chair and Mr. Hanna began participating in the hearing. Mr. Maslak recused himself from further deliberations in this hearing as Mr. Corpus was a former employee.

**RES. 98-016**

The hearing resumed after the Board had the opportunity to complete the review of the documentation submitted by Peter Corpus, R.Ph. Mrs. Neuber moved that the hearing be continued to a later date due to the lack of sufficient documentation showing that Mr. Corpus had complied with his Board Order dated June 30, 1994. The hearing is not to be scheduled until Mr. Corpus can produce documentation of at least one year's worth of continuous compliance after the mailing date of the Board's letter notifying him of this continuance. Documentation must include at least the following:

- (1) Copy of a signed contract with a Board-approved treatment provider;
- (2) Attendance at three AA/NA meetings per week; and
- (3) Urine screens as outlined in his Board Order that document the pH of the urine and show the measurement of specific gravity or creatinine as a dilutional test.

The motion was seconded by Mr. Hanna and approved by the Board (Aye-7/Nay-0/-Abstain-1[Maslak]).

#### FINDINGS OF FACT

After having heard the testimony, considered the evidence, observed the demeanor of the witnesses, and weighed their credibility, the State Board of Pharmacy finds the following to be fact:

- (1) Records of the Board indicate that James Brian Bird submitted an application for Examination as a Pharmacist on or about November 27, 1996.
- (2) Records further indicate that on or about March 14, 1994, the Board found the following to be fact:

- (a) Records of the State Board of Pharmacy indicate that James Brian Bird was originally licensed to practice pharmacy in the state of Ohio by reciprocity on December 2, 1980, and was summarily suspended on April 29, 1993. Further, James Brian Bird admitted in his testimony that he was the responsible pharmacist during all relevant time periods as stated in the paragraphs below.
- (b) James Brian Bird did, on or about December 22, 1992, and dates prior thereto, practice pharmacy at the Medicine Shoppe, 555 W. High Street, New Philadelphia, Ohio, when addicted to drugs. James Brian Bird admitted that he abused Percodan, Percocet, Tylox, and their generic equivalents. Thus, he is addicted to or abusing liquor and/or drugs or impaired physically or mentally to such a degree as to render him unfit to practice pharmacy.
- (c) James Brian Bird did, between August 10, 1991, and December 2, 1992, sell controlled substances in an amount less than the minimum bulk amount when the conduct was not in accordance with Chapters 3719. and 4729. of the Revised Code, to wit: James Brian Bird sold 115 units of Dexedrine 5mg, a schedule II controlled substance, without prescriptions and/or without a legitimate medical purpose. Such conduct is in violation of Section 2925.03(A)(1) of the Ohio Revised Code.
- (d) James Brian Bird, as the responsible pharmacist did, between August 10, 1991, and December 2, 1992, knowingly sell, under the definition of Sections 3719.01(EE) and 4729.02(J) of the Revised Code, a controlled substance in an amount less than the minimum bulk amount when the conduct was not in accordance with Chapters 3719. and 4729. of the Revised Code, to wit: James Brian Bird and/or a pharmacist under his control sold 172 units of Xanax 0.25mg, a schedule IV controlled substance, without prescriptions and/or without a legitimate medical purpose. Such conduct is in violation of Section 2925.03(A)(1) of the Ohio Revised Code.
- (e) James Brian Bird did, between August 10, 1991, and December 2, 1992, sell a controlled substance in an amount equal to or exceeding the bulk amount, but in an amount less than three times that amount, when the conduct was not in accordance with Chapters 3719. and 4729. of the Revised Code, to wit: James Brian Bird sold, for his own purposes, 65 units of Percodan and/or generic equivalents, a schedule II controlled substance, without prescriptions and/or without a legitimate medical purpose. Such conduct is in violation of Section 2925.03(A)(5) of the Ohio Revised Code.
- (f) James Brian Bird did, between August 10, 1991, and December 2, 1992, sell controlled substances in an amount equal to or exceeding three times the bulk amount, but in an amount less than one hundred times that amount, when the conduct was not in accordance with Chapters 3719. and 4729. of the Revised Code, to wit: James Brian Bird sold 755 units of Tylox and/or generic equivalents, and 156 units of Dilaudid 4mg, schedule II controlled substances, without prescriptions and/or without a legitimate medical purpose. Such conduct is in violation of Section 2925.03(A)(7) of the Ohio Revised Code.
- (g) James Brian Bird did, between August 10, 1991, and December 2, 1992, sell controlled substances in an amount equal to or exceeding three times the bulk amount, but in an amount less than one hundred times that amount, when the conduct was not in accordance with Chapters 3719. and 4729. of the Revised Code, to wit: James Brian Bird sold 300 units of APAP 325mg/Codeine 30mg, and 990ml of Hycodan Syrup, schedule III controlled substances, without prescriptions and/or without a legitimate

medical purpose. Such conduct is in violation of Section 2925.03(A)(7) of the Ohio Revised Code.

- (h) James Brian Bird did, between August 10, 1991, and December 2, 1992, sell controlled substances in an amount equal to or exceeding three times the bulk amount, but in an amount less than one hundred times that amount, when the conduct was not in accordance with Chapters 3719. and 4729. of the Revised Code, to wit: James Brian Bird sold 3,600 units of Diazepam 5mg, a schedule IV controlled substance, without prescriptions and/or without a legitimate medical purpose. Such conduct is in violation of Section 2925.03(A)(7) of the Ohio Revised Code.
- (i) James Brian Bird did, between August 10, 1991, and December 2, 1992, sell controlled substances in an amount equal to or exceeding one hundred times the bulk amount, when the conduct was not in accordance with Chapters 3719. and 4729. of the Revised Code, to wit: James Brian Bird sold 5,645 units of Percocet and/or generic equivalents, a schedule II controlled substance, without prescriptions and/or without a legitimate medical purpose. Such conduct is in violation of Section 2925.03(A)(10) of the Ohio Revised Code.
- (j) James Brian Bird did, between April 30, 1990, and April 30, 1993, sell controlled substances in an amount equal to or exceeding three times the bulk amount, but in an amount less than one hundred times that amount, when the conduct was not in accordance with Chapters 3719. and 4729. of the Revised Code, to wit: James Brian Bird sold the following schedule IV controlled substances without prescriptions and/or without a legitimate medical purpose:

Such conduct is in violation of Section 2925.03(A)(7) of the Ohio Revised Code.

- (k) James Brian Bird did, between April 30, 1990, and April 30, 1993, sell, under the definition of Sections 3719.01(EE) and 4729.02(J) of the Revised Code, a controlled substance in an amount equal to or exceeding the bulk amount, but in an amount less than three times that amount, when the conduct was not in accordance with Chapters 3719. and 4729. of the Ohio Revised Code, to wit: James Brian Bird or a pharmacist under his control sold 42 units of Ionimin 30mg, a schedule IV controlled substance, without prescriptions and/or without a legitimate medical purpose. Such conduct is in violation of Section 2925.03(A)(5) of the Ohio Revised Code.
- (l) James Brian Bird did, on or about the following dates, make or utter false or forged prescriptions for dangerous drugs, to wit: James Brian Bird created false or forged prescriptions in the name of patient Linda Hanner, not authorized by a practitioner for the following dangerous drugs:

- (m) James Brian Bird did, on or about the following dates, make or utter false or forged prescriptions for dangerous drugs, to wit: James Brian Bird created false or forged telephone prescriptions in the name of patient Willard Hanner, not authorized by a practitioner for the following dangerous drugs:

Such conduct is in violation of Section 4729.61(C) of the Ohio Revised Code.

- (n) James Brian Bird did, from on or about April, 1990, through February, 1993, furnish to another controlled substances when the conduct was not in accordance with Chapters 3719., 4715., 4729., 4731., and/or 4741. of the Ohio Revised Code, to wit: due to illegal sales of Diazepam 5mg, a schedule IV controlled substance, to Jean Lahmers, James Brian Bird caused her to become drug dependent. Such conduct is in violation of Section 2925.02(B) of the Ohio Revised Code.
- (o) James Brian Bird, as the responsible pharmacist did, between August 10, 1991, and December 2, 1992, sell, under the definition of Sections 3719.01(EE) and 4729.02(J) of the Revised Code, a controlled substance in an amount less than the minimum bulk amount when the conduct was not in accordance with Chapters 3719. and 4729. of the Revised Code, to wit: James Brian Bird or a pharmacist under his control sold 480ml of Methadone oral solution 5mg/5ml, a schedule II controlled substance, without prescriptions and/or without a legitimate medical purpose. Such conduct is in violation of Section 2925.03(A)(1) of the Ohio Revised Code.
- (p) James Brian Bird, as the responsible pharmacist did, between August 10, 1991, and December 2, 1992, sell, under the definition of Sections 3719.01(EE) and 4729.02(J) of the Revised Code, controlled substances in an amount equal to or exceeding the bulk amount, but in an amount less than three times that amount, when the conduct was not in accordance with Chapters 3719. and 4729. of the Revised Code, to wit: James Brian Bird or a pharmacist under his control sold the following schedule II controlled substances without prescriptions and/or without a legitimate medical purpose:

Methylphenidate Extended Release 20mg	201

Such conduct is in violation of Section 2925.03(A)(5) of the Ohio Revised Code.

- (q) James Brian Bird, as the responsible pharmacist did, between April 30, 1990, and April 30, 1993, sell, under the definition of Sections 3719.01(EE) and 4729.02(J) of the Revised Code, a controlled substance in an amount equal to or exceeding three times the bulk amount, but in an amount less than one hundred times that amount when the conduct was not in accordance with Chapters 3719. and 4729. of the Revised Code, to wit: James Brian Bird or a pharmacist under his control sold the following controlled substances without prescriptions and/or without a legitimate medical purpose:

Methylphenidate 10mg	II	1,118
Xanax 0.5mg	IV	1,208
Xanax 1mg	IV	940

Such conduct is in violation of Section 2925.03(A)(7) of the Ohio Revised Code.

- (r) James Brian Bird did, on or about December 21, 1993, plea guilty in the Court of Common Pleas of Tuscarawas County, Ohio, to fifteen counts of Trafficking in Drugs, in violation of Section 2925.03(A)(1) of the Ohio Revised Code.

The Board concluded that James Brian Bird was guilty of a felony and gross immorality; guilty of dishonesty and unprofessional conduct in the practice of pharmacy; addicted to and abusing liquor or drugs or impaired physically or mentally to such a degree as to render him unfit to practice pharmacy; and guilty of willfully violating, conspiring to violate, attempting to violate, or aiding and abetting the violation of provisions of 3715.52 to 3715.72 or Chapters 2925., 3719., or 4729. of the Revised Code within the meaning of Section 4729.16 of the Ohio Revised Code. Therefore, the Board revoked James Brian Bird's license, No. 03-2-13744, to practice pharmacy in the state of Ohio.

#### CONCLUSIONS OF LAW

- (1) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraph (2)(r) of the Findings of Fact constitutes being guilty of a felony as provided in paragraph (A) of Rule 4729-5-04 of the Ohio Administrative Code.
- (2) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraph (2)(r) of the Findings of Fact constitutes having been convicted of violating state or federal pharmacy or drug laws as provided in paragraph (B) of Rule 4729-5-04 of the Ohio Administrative Code.
- (3) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraphs (2)(b) through (2)(r) of the Findings of Fact constitute not being of good moral character and habits as provided in paragraph (C) of Rule 4729-5-04 of the Ohio Administrative Code.
- (4) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraph (2)(b) of the Findings of Fact constitutes being addicted to or abusing liquor or drugs as provided in paragraph (D) of Rule 4729-5-04 of the Ohio Administrative Code.

- (5) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraph (2) of the Findings of Fact constitutes having been disciplined by the Ohio State Board of Pharmacy pursuant to Section 4729.16 of the Revised Code as provided in paragraph (E) of Rule 4729-5-04 of the Ohio Administrative Code.

#### ACTION OF THE BOARD

Pursuant to Section 4729.08 of the Ohio Revised Code, and the foregoing Findings of Fact and Conclusions of Law, the State Board of Pharmacy hereby denies the issuance of a certificate of registration or an identification card, and therefore denies the Application for Examination as a Pharmacist submitted by James Brian Bird.

Further, James Brian Bird may not apply for examination as a pharmacist before one year from the date of this Order.

#### FINDINGS OF FACT

After having heard the testimony, considered the evidence, observed the demeanor of the witnesses, and weighed their credibility, the State Board of Pharmacy finds the following to be fact:

- (1) Records of the Board of Pharmacy indicate that James D. Parks is the president of BMW-Med-Tec of Ohio, Inc., pursuant to Section 4729.55 of the Ohio Revised Code.
- (2) BMW-Med-Tec of Ohio, Inc. did, on or about November 30, 1995, make a false statement, or swear the truth of a false statement, when made for the purpose to secure the issuance by the Board of Pharmacy, a governmental agency, of a terminal distributor's license, to wit: when applying for a terminal distributor's license, the facility indicated that no employee of the applicant had convictions for felonies or misdemeanors, when in fact Franklin D. Shrader, Jr., the plant manager, had the following convictions from various Tennessee courts:
  - (a) Judgment Entry dated January 6, 1984, Selling a Schedule VI (*sic* IV) Controlled Substance;
  - (b) Judgment Entry dated October 30, 1990, Simple Possession of Cocaine;
  - (c) Judgment Entry dated October 30, 1990, Possession of Drug Paraphernalia;
  - (d) Judgment Entry dated February 28, 1994, Sale of Marijuana;
  - (e) Judgment Entry dated August 14, 1995, Possession of Cocaine; and
  - (f) Judgment Entry dated August 14, 1995, Driving While Revoked.

Such conduct is in violation of Section 2921.13 of the Ohio Revised Code.

#### CONCLUSION OF LAW

- (1) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraph (2) of the Findings of Fact constitutes making false material statements in an application for a license as a terminal distributor of dangerous drugs as provided in Division (A)(1) of Section 4729.57 of the Ohio Revised Code.

FINDINGS OF FACT

After having heard the testimony, considered the evidence, observed the demeanor of the witnesses, and weighed their credibility, the State Board of Pharmacy finds the following to be fact:

- (1) On September 17, 1996, Keith Jered Hochadel was notified by letter of his right to a hearing, his rights in such hearing, and his right to submit his contentions in writing.
- (2) As demonstrated by return receipt of September 24, 1996, Keith Jered Hochadel received the letter of September 17, 1996, informing him of the allegations against him, and his rights.
- (3) On March 21, 1997, Keith Jered Hochadel was notified by letter of additional charges filed against him, his right to a hearing in this matter, his rights in such hearing, and his right to submit his contentions in writing.
- (4) As demonstrated by return receipt of March 24, 1997, Keith Jered Hochadel received the letter of March 21, 1997, informing him of the allegations against him, and his rights.
- (5) Keith Jered Hochadel requested a hearing in these matters and a hearing was scheduled in accordance with Chapter 119. of the Ohio Revised Code; however, Keith Jered Hochadel nor his counsel of record were present for the hearing.
- (6) Records of the Board indicate that Keith Jered Hochadel was originally licensed to practice pharmacy in the state of Ohio on March 1, 1985. On September 17, 1996, Keith Jered Hochadel's license was summarily suspended in accordance with Section 3719.121(B) of the Ohio Revised Code.
- (7) Keith Jered Hochadel did, from August of 1995 through September 13, 1996, knowingly obtain or use a controlled substance when the conduct was not in accordance with Chapters 3719., 4729., and 4731. of the Ohio Revised Code, to wit: Keith Jered Hochadel admitted to an agent of the Ohio Board of Pharmacy that he continually ingested Hydrocodone with APAP 7.5mg and Hydromet cough syrup without a prescription. Such conduct is in violation of Section 2925.11 of the Ohio Revised Code.
- (8) Keith Jered Hochadel is abusing controlled substances to such a degree as to render him unfit to practice pharmacy, to wit: while practicing pharmacy Keith Jered Hochadel stole controlled substances; Keith Jered Hochadel admitted to an agent of the Ohio Board of Pharmacy that on occasion, while practicing pharmacy, he consumed Hydrocodone with APAP 7.5mg, a schedule III controlled substance, without a prescription; and, Keith Jered Hochadel failed to keep accountability records such as dispensing reports, wholesale purchase records, and Drug Enforcement Administration (D.E.A.) controlled substances inventories. Such conduct falls within the ambit of Section 4729.16(A)(3) of the Ohio Revised Code.
- (9) Keith Jered Hochadel did, from August 17, 1996 through September 13, 1996, with purpose to deprive, knowingly obtain or exert control over dangerous drugs, the property of Revco #2393, beyond the express or implied consent of the owner, to wit: Keith Jered Hochadel admitted to an agent of the Ohio Board of Pharmacy that he stole Hydrocodone with APAP 7.5mg; subsequently, an audit revealed a shortage of 237 unit doses of Hydrocodone with APAP 7.5mg, a schedule III controlled substance. Such conduct is in violation of Section 2913.02 of the Ohio Revised Code.
- (10) Keith Jered Hochadel as the Responsible Pharmacist did, on or about January or February, 1995, fail to notify the Board of Pharmacy and the D.E.A. upon discovery of

the theft of controlled substances, to wit: after a breaking and entering and theft had occurred at Mt. Union Square Pharmacy, Keith Jered Hochadel admittedly decided not to report the matter so as to protect the suspected thief. Such conduct is in violation of Rule 4729-9-15 of the Ohio Administrative Code.

- (11) Keith Jered Hochadel as the Responsible Pharmacist did, on or about September 6, 1996, fail to file a discontinuing business form with the Board when Mt. Union Square Pharmacy sold its business to Revco and discontinued, to wit: on August 7, 1996, Revco formally purchased Mt. Union Square Pharmacy, and Keith Jered Hochadel as the Responsible Pharmacist did not file the proper forms. Such conduct is in violation of Rule 4729-9-07 of the Ohio Administrative Code.
- (12) Keith Jered Hochadel as the Responsible Pharmacist did, on or about September 13, 1996, and dates immediately preceding, fail to keep all records of drug accountability belonging to Mt. Union Square Pharmacy on site at the location of the licensed facility where the dangerous drugs were located, to wit: records of dispensing and inventory were maintained at Keith Jered Hochadel's home and in a rental storage area adjacent to the pharmacy. Such conduct is in violation of Rule 4729-9-22 of the Ohio Administrative Code.
- (13) Keith Jered Hochadel as the Responsible Pharmacist did, on or about September 13, 1996, fail to maintain a "three part filing system" wherein prescriptions for schedule II controlled substances are filed separate from prescriptions for schedule III, IV, and V controlled substances, which are filed separate from prescriptions for dangerous drugs. Such conduct is in violation of Rule 4729-5-09 of the Ohio Administrative Code.
- (14) Keith Jered Hochadel as the Responsible Pharmacist did, on or about September 13, 1996, and on dates immediately preceding, fail to take and maintain on file a D.E.A. biennial inventory, to wit: Keith Jered Hochadel started but did not complete controlled substance inventories dated 8-25-94, 5-1-95, 1-31-96, and 5-1-96. Such conduct is in violation of Section 1304.16 of the Code of Federal Regulations.
- (15) Keith Jered Hochadel did, from May 1, 1995, through August 6, 1996, with purpose to deprive, knowingly obtain or exert control over dangerous drugs, the property of Mt. Union Square Pharmacy, beyond the express or implied consent of the pharmacy, to wit: Keith Jered Hochadel stole the following controlled substances:

Such conduct is in violation of Section 2913.02 of the Ohio Revised Code.

- (16) Keith Jered Hochadel did, from August 6, 1996, through September 14, 1996, with purpose to deprive, knowingly obtain or exert control over dangerous drugs, the property of Revco #2393, beyond the express or implied consent of the pharmacy, to wit: Keith Jered Hochadel stole the following controlled substances:

#### CONCLUSIONS OF LAW

- (1) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraphs (7), (9), and (15) through (21) of the Findings of Fact are acts that would constitute a felony as provided in Division (A)(1) of Section 4729.16 of the Ohio Revised Code.
- (2) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraphs (7), (8), (9), and (15) through (21) of the Findings of Fact are acts that would constitute gross immorality as provided in Division (A)(1) of Section 4729.16 of the Ohio Revised Code.
- (3) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraphs (7) through (17) of the Findings of Fact constitute being guilty of dishonesty and unprofessional conduct in the practice of pharmacy as provided in Division (A)(2) of Section 4729.16 of the Ohio Revised Code.
- (4) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraphs (7) and (8) of the Findings of Fact constitute being addicted to or abusing drugs or impaired physically or mentally to such a degree as to render him unfit to practice pharmacy as provided in Division (A)(3) of Section 4729.16 of the Ohio Revised Code.
- (5) Upon consideration of the record as a whole, the State Board of Pharmacy concludes that paragraphs (7) and (17) through (21) of the Findings of Fact constitute being guilty of willfully violating, conspiring to violate, attempting to violate, or aiding and abetting the violation of provisions of Chapter 2925. or 4729. of the Revised Code as provided in Division (A)(5) of Section 4729.16 of the Ohio Revised Code.

## ACTION OF THE BOARD

Pursuant to Section 3719.121 of the Ohio Revised Code, the State Board of Pharmacy hereby removes the Summary Suspension Order issued to Keith Jered Hochadel.

Pursuant to Section 4729.16 of the Ohio Revised Code, the State Board of Pharmacy takes the following actions in the matter of Keith Jered Hochadel:

- (A) On the basis of the Findings of Fact and paragraph (1) of the Conclusions of Law set forth above, the State Board of Pharmacy hereby revokes the pharmacist identification card, No. 03-3-15826, held by Keith Jered Hochadel effective as of the date of the mailing of this Order.
- (B) On the basis of the Findings of Fact and paragraph (2) of the Conclusions of Law set forth above, the State Board of Pharmacy hereby revokes the pharmacist identification card, No. 03-3-15826, held by Keith Jered Hochadel effective as of the date of the mailing of this Order.
- (C) On the basis of the Findings of Fact and paragraph (3) of the Conclusions of Law set forth above, the State Board of Pharmacy hereby revokes the pharmacist identification card, No. 03-3-15826, held by Keith Jered Hochadel effective as of the date of the mailing of this Order.
- (D) On the basis of the Findings of Fact and paragraph (4) of the Conclusions of Law set forth above, the State Board of Pharmacy hereby revokes the pharmacist identification card, No. 03-3-15826, held by Keith Jered Hochadel effective as of the date of the mailing of this Order.
- (E) On the basis of the Findings of Fact and paragraph (5) of the Conclusions of Law set forth above, the State Board of Pharmacy hereby revokes the pharmacist identification card, No. 03-3-15826, held by Keith Jered Hochadel effective as of the date of the mailing of this Order.

Division (B) of Section 4729.16 of the Ohio Revised Code provides: "Any individual whose identification card is revoked, suspended, or refused, shall return his identification card and certificate of registration to the offices of the state board of pharmacy within ten days after receipt of notice of such action." The certificate and identification card should be forwarded by certified mail, return receipt requested.

THIS ORDER WAS APPROVED BY A VOTE OF THE STATE BOARD OF PHARMACY.

The motion was seconded by Mrs. Plant and approved by the Board (Aye-6/Nay-0/Abstain-1[Cavendish]). Mr. Cavendish did not participate in adjudicating this matter since he was not able to be present for the full hearing.

**RES. 98-025** The Board next considered correspondence from both Cigna and Med-Direct regarding transfer of prescription information by computer. Board staff was instructed to discuss the requirements of positive identification as defined in Rule 4729-5-01 of the Ohio Administrative Code with both companies. After this problem is resolved, the Board will reconsider the programs.

**RES. 98-026** The response to the Board's Cease and Desist letter to Magic Herb was discussed. The proposed new label for the product "Magic Herb" was reviewed for compliance with the new labeling requirements for ephedrine-containing products as found in Section 3719.44 of the Ohio Revised Code. The Board instructed staff to notify the manufacturer that Ohio law requires that the actual ephedrine content be specified on the label rather than the content of ephedra alkaloids.

The response to the Board's Cease and Desist letter to Kmart Corporation regarding recent advertisements was distributed to the Board for their information.

**RES. 98-027** A request from WestLaw Publishing Company to provide a link between their Internet HomePage and the Board's was approved by the Board.

Copies of a letter received from the Ohio Inspector General closing his case involving Thomas J. Hutton's complaint against the Board were distributed to the Board members.

Information received from Barr Laboratories regarding their warfarin product that was recently approved by the FDA was discussed by the Board. No action was required in this matter.

A letter addressed to Larry Weaver, Office of Budget and Management, setting forth the proposed meeting agenda of the Joint Working Group of Health Care Regulatory Boards was distributed to the Board members for their review. Board staff will attend the meeting.

A request from the National Notification Center (NNC) that the Board add a link to the NNC from the Board's HomePage was considered. The Board instructed staff to obtain further information about the NNC prior to the September Board meeting. The matter will be discussed further at that time.

Copies of the draft response to the FDA about their proposed rules dealing with dietary supplements containing ephedrine were distributed to the Board members. The members present agreed to review the draft and notify the Board office of any proposed changes.

Timothy Benedict, Compliance Administrator, joined the Board to present a report on the status of those licensees currently on probation with the Board.
