The motion was seconded by Ms. Rudell and approved by the Board: Aye – 3, Nay – 2.

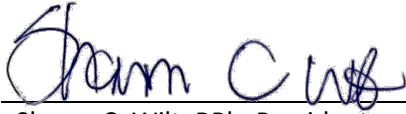
Mr. Weaver joined the call.

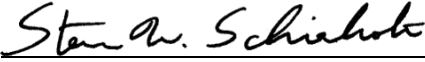
