

# E-News Update July 2019

#### Sale of Products Derived from Hemp

Recent changes to Ohio law (<u>SB 57</u>) removed hemp and hemp products containing no more than three-tenths of a percent THC from the state's definition of marijuana. Hemp products, including hemp derived CBD (cannabidiol), can now be sold outside of a licensed medical marijuana dispensary.

SB 57 also established a Hemp Cultivation and Processing Program. The Ohio Department of Agriculture is charged with the licensure of hemp cultivators and processors.

### Flushing of Hazardous Pharmaceuticals is Prohibited by U.S. EPA

U.S. EPA's final rule for Hazardous Waste Pharmaceuticals prohibits healthcare facilities and reverse distributors, as defined by U.S. EPA, from flushing, pouring, or draining hazardous pharmaceutical wastes down a toilet, sink, tub, or other drains as a disposal option. **This new rule will become effective in Ohio on August 21, 2019.**

## **Verification of License Prior to the Purchase of Dangerous Drugs**

As a reminder, before a terminal distributor of dangerous drugs may purchase dangerous drugs at wholesale, the terminal distributor is required by Ohio law to verify either of the following:

- The seller is licensed to engage in the sale of dangerous drugs in accordance with section 4729.52 of the Revised Code (i.e. the seller is licensed in Ohio as a manufacturer of dangerous drugs, outsourcing facility, third-party logistics provider, repackager of dangerous drugs or wholesale distributor of dangerous drugs).
- The seller is licensed to engage in the occasional sale or distribution of dangerous drugs at wholesale in accordance with OAC 4729:5-3-09.

Verification of licensure requirements for terminal distributors can be found in OAC 4729:5-3-04.

#### **Reminder: Responsible Person Requirements**

As a reminder, all locations licensed as a terminal distributor or drug distributor must have a responsible person at all times. When there is a change of responsible person, the licensees must notify the Board within 10 days of the effective date of the appointment of the new responsible

person.

The requirements for a responsible person are provided in the following rules:

- Terminal distributor of dangerous drugs (OAC 4729:5-2-01)
- Drug distributor of dangerous drugs (OAC 4729:6-2-01)

The change in responsible person must be made in <u>eLicense</u>. While it is the responsibility of the terminal distributor or drug distributor to notify the Board, the person who leaving their role as responsible person should verify that they are no longer listed on the license.

#### Reminder: Pharmacist License Renewal
