



Reciprocity Review and Quiz Guidance Document

The Ohio Board of Pharmacy now offers a convenient online review and quiz for out-of-state pharmacists applying for licensure via reciprocity. This document explains how to access the Reciprocity Review and Quiz as well as some important resources to help you succeed.

The Board's Reciprocity Review and Quiz is designed to provide applicants with critical knowledge on the laws and rules governing the practice of pharmacy. It is designed in two parts.

1. First, applicants should review all 16 law and rule review videos and familiarize themselves with the guidance documents referenced in each video. This should take approximately 60-75 minutes.
2. Next, applicants will be required to successfully complete a scored quiz component. To pass the quiz, you must obtain a score of 75% (12 out of 16 questions). You **ONLY** have three attempts to pass this quiz. Failure to pass the quiz within three attempts will result in your application being abandoned and application fee forfeited. In addition, you only have six months to complete the review and quiz before your application is deemed abandoned and application fee forfeited.

NOTE: To access the Reciprocity Review and Quiz, the Board's Licensing Department will send an email with instructions once the reciprocity applicant has submitted all of the required application materials. Please be advised that the Reciprocity Review and Quiz are the last steps in the reciprocity process and cannot be accessed without a completed application.

2. The Reciprocity Review and Quiz will require you to log in with your Application Number and Security Code. You will receive your Security Code via email from the Board of Pharmacy after the applicant has submitted their required application materials. Then click “Log In.”

IMPORTANT: Applicants who have not submitted a completed application to the Board will not be eligible to complete the Reciprocity Review and Quiz. Applicants will be notified via email from the Board's Licensing Department when they are eligible to take the Review and Quiz.

3. Once you log in, you will see the Reciprocity Quiz questions on the right side of the screen and a Navigation and Videos bar to the left.

6. There is also a Navigation bar at the top of the page that allows an applicant to:
- **Save Progress:** Allows to save the progress of their quiz and come back to it later.
 - **Help:** Send an email to the Board about any questions or concerns they have regarding the quiz.
 - **Download Quiz Copy:** Downloads a physical copy of the quiz.
 - **Logout:** Logs the applicant out of the review and quiz.

NOTE: Remember to click “Save Progress” on the quiz before clicking “Logout” so your quiz answers are saved for later.

At the top of the quiz page, it will tell you that you have failed the quiz and it gives you the number of questions you got correct.
